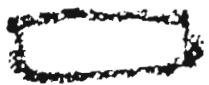

BERNARD HARDEN PORTER, AKA, DEPARTMENT OF THE NAVY, SGE.
 REBULET TO LOS ANGELES MAY FOURTEEN LAST. CARD OF PERSONNEL
 SECTION, FEDERAL AVIATION AGENCY, ANCHORAGE, REFLECTS PORTER
 EMPLOYED BY CIVIL AERONAUTICS ADMINISTRATION AS ELECTRONICS
 ENGINEER FROM MARCH ONE, NINETEEN FIFTYEIGHT, TO AUGUST TWO,
 NINETEEN FIFTYEIGHT, WHEN HE RESIGNED TO QUOTE RETURN TO
 PRIVATE PRACTICE IN CALIFORNIA UNQUOTE. HE WAS REINSTATED
 AUGUST TWENTYSEVEN, FIFTYEIGHT, AND RESIGNED SEPTEMBER EIGHT,
 FIFTYEIGHT, GIVING AS REASON QUOTE ON ADVICE OF PHYSICIAN
 UNQUOTE. PERSONNEL RECORDS REFLECT PORTER CONSIDERED AN
