BENIAH LONGLEY WHITMAN, D.D.

Rev. Beniah Longley Whitman, D.D., a prominent Baptist minister and former president of Colby College died in Seattle, Washington, on November 27.

Dr. Whitman was born in Wilmot, N. S., in 1862. He was a graduate of Worcester Academy, Brown University and Newton Theological Institute. His first pastorate was at the Free Street Baptist Church in Portland. In 1892, Dr. Whitman left Portland to become President of Colby College. Dr. Whitman remained at Colby three years, resigning in 1895 to become President of Columbian, now George Washington, University, at Washington, D. C.

In 1900, he resigned to accept the pastorate of a church in Philadelphia. From there, he went to Seattle in 1903, where he remained until his death.

ATHLETIC ASSOCIATION.

The regular meeting of the Executive Committee of the Athletic Association was

held Thursday afternoon, November 23.

Football letters were awarded to Captain Bagnell, Hamilton, Thompson, S. Soule, Beach, Bowler, Good, Joy, Keppel, C. Soule, Pratt, Weir, Crossman, Fraser, Ladd, Pendergast, Royal, and Manager Knight. No election of a manager for next year occurred.

The proposed constitution was discussed, and a committee appointed to consider further amendments.

At a special meeting of the executive committee, Monday, Frank D. Nardini, '13, was chosen to fill the vacancy in the 1913 delegation. Frederick A. Hunt, '13, was granted a C in consideration of the fact that he had been out of the championship games from injuries. M. Philip Roberts, '13, was elected manager of football. A slate of officers was drawn up. The name of Victor A. Gilpatrick was proposed as assistant manager of baseball.

NEW CONSTITUTION.

A meeting of the Athletic Association was held on Monday evening to consider the new constitution. After considerable discussion, it was voted to adopt the constitution as printed in the ECHO, and to appoint a committee of five to submit such amendments as in their judgment would be advantageous. The committee chosen consisted of Hogan, '12, Rideout, '12, Chapman, '12, Jackman, '12, and Merrill, '14.

The committee appointed by the Athletic Association has completed its duties. The draft as finally presented to the Association is practically that of the committee appointed by the Executive Committee to consider further revisions. It differs from the present constitution mainly by creating

the office of graduate manager and reducing the size of the Council to eight members. This draft, which meets the approval of the committee of faculty, alumni, and students as well as the student committee, is published in this number of the ECHO and will be presented for ratification at a special meeting of the Association on Tuesday evening.

In its report the committee will recommend the adoption of the constitution to take effect on Friday, December 15. They will further recommend that on that date the Association hold a special meeting for the election of officers. This will enable members of the Association to post the names of candidates as required by the constitution.

DEKES WIN DRUID CUP.

The cup offered by the Junior Society of Druids for the fraternity holding the highest average rank in scholarship has been awarded to the Delta Kappa Epsilon fraternity for the year of 1910-11. Announcement has been delayed on account of incomplete courses. The fraternities ranked in the following order: Delta Kappa Epsilon, Alpha Tau Omega, Delta Upsilon, Zeta Psi, and Phi Delta Theta.

This is the first year that the cup has been offered. It is to remain in the possession of the winning fraternity for the period of one year. Any fraternity holding the cup for three successive years will have permanent possession of it.

DEBATING LEAGUE.

Eight schools have accepted the invitation of the Colby Debating Society to form an Interscholastic Debating League. Coburn Classical Institute, Higgins Classical Institute, Oak Grove Seminary, Maine Central Institute, Good Will High School, Hallowell High School, Skowhegan High School, and Waterville High School. During the week of January 8, preliminary debates will be held between Coburn and

Higgins, Oak Grove and M. C. I., Good Will and Hallowell, Skowhegan and Waterville. The winners of the first two debates and those of the last two will hold semi-final debates during the week of January 22. To each of the winning teams in these semi-final debates, a prize of twenty-five dollars will be given. During the week of February 19, the final debate will be held at Colby. To the winning team in this debate a prize of \$50 will be given.

Each team in the league will be under the immediate charge of coaches appointed by the Colby Debating Society. The coaches will have general supervision of the work of their teams; but will not be allowed to write the debates. Their duties are simply of an advisory and critical nature. The coaches and teams will be allowed to obtain help in their work, but in all cases the arguments are to be composed by the members of the teams. The contests will be handled by the members of the Debating Society, which will furnish judges and presiding officers from its members.

By the formation of this league, it is hoped to stimulate an interest in debating and public speaking among the preparatory schools of the state. It is an additional step in the work so successfully done during the past two years by the Lyford Prize Speaking Contests.

EDITOR COLBY ECHO:

President Roberts did the South Boston High School the honor to visit us today and to address us. The assembly room was filled to its utmost capacity and we regret that any pupils could not be present to hear him. His address was inspiring and most helpful, as was acknowledged by frequent applause and has been since expressed by teachers in emphatic terms. He spoke on the need of the youth of today to prepare themselves for the best work in life in the midst of competition which is constantly to be encountered and in which the highest preparation is to be found and is constantly improving in quality. He instanced various professions to which a college education would lead. He showed the necessity of preparing for those professions by college education. He admitted that there were obstacles, many of which can be overcome, and he explained how to overcome them. He also showed, instancing the late Mayor Patrick Collins, how a young man of ambition and initiative and self-help can educate himself, as Mr. Collins prepared between the ages of ten and twenty-one by personal study in the Public Library five evenings a week to enter Harvard Law School.

President Roberts' address will be long remembered and will exert a lasting influence on those who heard it. I hope we may have pupils in the school prepare for Colby. I propose to be a Consultor for Colby, as we have Consultors for all higher institutions for which our pupils are preparing.

Assistant Superintendent Jeremiah E. Burke, a classmate of President Roberts, was present and was compelled by the audience to address, as he did most happily, showing an application of what President Roberts had said to the character and lives of our pupils.

COLBY ATHLETIC ASSOCIATION.

Constitution.

NAME.

ARTICLE I.

This Association shall be known as the Colby Athletic Association.

PURPOSE.

ARTICLE II.

Its purpose shall be to direct and control all the athletic sports and contests in which the membership of the Association is interested, to look after the athletic interests of Colby College, and to have in charge the athletic field and any other properties belonging to the Association. (In accordance with a former agreement with the college, one-half of the expense of keeping in repair the grand-stand, fence, etc., shall be borne by the Association and the other half by the college.)

MEMBERSHIP.

ARTICLE III.

All students of Colby College, all members of the college faculty, and all alumni, alumnae, and former students of the college are eligible to membership in the Association. Students of the college upon signifying in writing their intention to pay the annual dues during their connection with the college, become members of the Association without any further formality: others eligible to membership become members of the Association on payment of the annual dues as provided in Article IV.

FINANCES.

ARTICLE IV.

Section 1. Every member of the Association shall be subject to yearly dues, amounting to \$10.00, in the case of the student of the men's college, of which \$5.00 shall be payable in the first semester of the college year, and \$5.00 in the second semester. In the case of the students of the women's college, the dues shall be \$4.00 annually, \$2.00 of which shall be payable in the first semester of the college year, and \$2.00 payable in the second semester. In the case of the alumni, alumnae, and faculty, the dues shall be \$3.00 annually, which shall entitle them to free admission to games, or of \$1.00 annually which shall not entitle them to free admission to games.

Section 2. The dues of the student members may be assessed upon the college term bills, for the terms when the several installments become due, and may be collected in the same manner as the ordinary college charges.

Section 3. Any member of the Association who fails to pay any installment of the annual dues shall

be debarred from all the privileges of membership in the Association; but upon payment of his arrears, and upon his declaration in writing that he desires to connect himself again with the Association, he may be reinstated into full membership by the Council.

PRIVILEGES OF MEMBERS.

ARTICLE V.

Section 1. All members of the Association are eligible to hold office in the Association, except when prohibited by other portions of this constitution. They may vote at the annual and special meetings, and may have a voice in the discussions attending the transaction of business at these meetings.

Section 2. Student members of the Association are eligible to positions on all the athletic teams representing the Association, provided they comply with the rules and conditions imposed in each case by the Council.

Section 3. No student not a member of this Association shall be a member of any athletic team representing the Association, except by vote of the Council; nor shall any such person be eligible to office in the Association.

Section 4. All members of the Association, except alumni and alumnae members paying annual dues of \$1.00, shall have free admission to all contests and games held by the Association on the college grounds except on special occasions when the Association may vote otherwise.

OFFICERS.

ARTICLE VI.

Section 1. The affairs of the Association shall be managed by an executive committee, known hereafter as the Council, who shall exercise all powers not reserved to the Association, or otherwise delegated by this constitution.

Section 2. This Council shall consist of seven members: two members from the alumni, elected by the alumni; two members from the faculty, elected by the faculty; two members from the student body, elected by the Association; and the President of the Association, ex officio. There shall be present at the meetings of the Council, the Director of Physical Training, a Treasurer, to be elected by the Council; a Graduate Manager, to be elected by the Council; and the various Managers, to be elected by the Association.

Section 3. The Managers shall be elected at the first regular meeting of the Association after the close of their season by ballot in the following manner.

The Council shall propose the names of one or more candidates and shall post their names at least one week previous to the meetings of the Association.

tion. Any other members of the Association may nominate any other candidate for the office by posting his name at least three days before the meeting. The Assistant Manager shall be chosen in a similar manner at the same meeting.

Section 4. A President of the Association and the student members of the Council shall be elected at the June meeting of the Association, in the same manner as the managers. The President shall be a member of the senior class during his term of office.

Section 5. The Council shall recommend to the Colby Alumni Association at the annual meeting candidates for the Council.

Section 6. Vacancies in offices not filled by the Council shall be filled at a special meeting of the Association called for that purpose.

Section 7. At the first meeting of the Council, they shall choose a Treasurer from the faculty, Secretary from the undergraduate members of the Council, and a Graduate Manager. The Secretary shall act as Secretary of the Association.

DUTIES OF OFFICERS.

ARTICLE VII.

Section 1. The President, Secretary and Treasurer shall perform the duties usually pertaining to their respective offices.

Section 2. The Council shall direct the policy of the Association and shall be the board of appeal, to which all controversies that may arise in the Association shall be referred.

The council may require the resignation of any official who proves himself incompetent or unwilling to discharge his duties, and may fill temporarily any position that may for any reason be vacant.

Section 3. The Graduate Manager shall have direct oversight of the work of the managers; supervision of the arranging of schedules for athletic contests, of the purchase of supplies for the Association and of the care of its property; and shall be entrusted with the correct expenditure of money voted by the Council; and shall report at each meeting of the Council. All bills shall be paid by the Treasurer by check on vouchers signed by the Graduate Manager, who shall keep a record of all authorized expenditures. In case of vacancy in the office of Graduate Manager, its duties shall devolve upon the Council.

Section 4. Under the supervision of the Graduate Manager, it shall be the duty of each Manager to attend to all business connected with any game or contest played by his respective team, to notify each member of his team qualified to vote, when and where the election of Captain is to occur, and to notify the Council of the result of the election.

Immediately upon his election to office, the Manager shall receive from the Graduate Manager, and

retain during the period of his managership, a "Property Book," in which he shall keep a complete detailed record of all property received or purchased by him, or used in connection with his department, together with an exact record of the disposition thereof, containing the names of the individuals to whom such has been delivered and date of delivery; and the said manager shall thereby account for all such property which has been either in his own or in the possession of any individual member of his department during the period of his managership.

It shall be the duty of each Manager to deliver to the Graduate Manager the "Property" and other books of record, not later than one week subsequent to the close of his athletic season.

No Manager shall sign any contracts or contract any bill, or incur any expense amounting in the aggregate to over \$10.00 without the written consent of the Graduate Manager.

Before taking any team out of town, the Manager shall submit the list of members to the Chairman of the Committee on Athletics of the Faculty and to the Director of Physical Training for their approval.

The Assistant Managers shall be under the direct supervision of their respective Managers and subject at all times to their direction.

Section 5. It shall be the duty of the Captains to collect the trophies of each game won and present them to the President of the Association, and to report all records made by their teams to the Council and to see that a proper record is made of them.

He shall report to the Council at the end of each season such men on his squad as are in his opinion entitled to wear a "C"; and shall have charge of his team on the field; and shall be held responsible for the decorum of his team while training or taking part in contests.

Section 6. The Director of Physical Training shall have charge of the physical condition of the men on all teams and no man shall enter any contest or practice contrary to his judgment.

A physician shall be appointed by the Council; and the Director of Physical Training shall send all players needing medical attendance to said physician, except when in his judgment it would be advisable to consult another physician; and the Association shall be responsible for all medical bills contracted for by the Director of Physical Training, but the Association shall not be responsible for such bills unless contracted for by the Director of Physical Training.

Section 7. The Treasurer shall pay all bills by check on written orders signed by the Graduate Manager.

The Treasurer shall keep an accurate account of all moneys passing through his hands and shall report at any time the Council may direct. At the close

of each year his books shall be audited by a committee appointed by the Council and then submitted to an auditor appointed by the Trustees of the College.

MEETINGS.

ARTICLE VIII.

Section 1. Regular meetings of the Association for the election of a football Manager and Assistant Manager and the transaction of other business shall be held on the first Saturday in December; and on the second Saturday in June, for the election of President of the Association, student members of Council, Managers, and Assistant Managers of the baseball, track and tennis teams, and for the transaction of any other business.

Section 2. Special meetings of the Association may be called at any time by the President, or by any member of the Council, upon the written request of ten members of the Association, provided the request specifies the purpose for which the meeting is desired.

Section 3. Special meetings of the Association may be called at any time by the Council for the transaction of special business.

Section 4. Notices calling special meetings must state the nature of the business which is to be discussed at said meeting.

Section 5. Fifty members shall constitute a quorum for the transaction of business at any meeting.

If, for any reason, a quorum shall not be present at any meeting, a majority of those present may adjourn said meeting to a later date, which must be mentioned in the motion of adjournment.

COLORS.

ARTICLE IX.

Section 1. The official color of the Association shall be a blue, corresponding to the permanent blue of Windsor and Newton's oil colors.

Section 2. On all public occasions, where it is desirable to use the color in decorations it shall be combined with the college color, silver gray. This use of the combined colors shall also apply to team and athletic suits.

AMENDMENTS.

ARTICLE X.

This constitution and the by-laws appended to it may be amended by a two-thirds vote of all the members voting at any business meeting of the Association, provided that at least one week previous to the date of the meeting at which it is to be voted upon, one copy of the proposed amendment has been given to the Council through the Secretary, and another copy has been posted.

SUSPENSION OF THE CONSTITUTION.

ARTICLE XI.

Any part of this constitution, including the by-laws, may be suspended at any legal meeting of the Association by the unanimous vote of the members present at said meeting.

By-Laws.

Rule 1. The Council shall hold weekly meetings.

Special meetings of the Council may be called by the President at any time.

Rule 2. The Captain shall report for a letter every member of the football squad who has played at least one whole game with any Maine college team, or some portion of each of the championship games, unless some cause exists for not doing so, which cause he shall report to the Council; and he may recommend for cause any other members of the squad for their letters.

The Captain shall report for a letter every member of the baseball squad who has played twenty-seven innings, and every pitcher who has pitched eighteen innings in the Maine Championship Series, unless some cause exists for not doing so, which cause he shall report to the Council; and he may recommend for cause any other member of the squad for their letters.

The Captain shall report for a letter every member of the track squad who has won a point in an intercollegiate meet, or who has won either a first or two seconds in an outdoor dual meet, or who has been a member of a winning relay team in an intercollegiate meet, or who has broken a college record; unless some cause exists for not doing so, which cause he shall report to the Council; and he may recommend for cause any other members of the squad for their letters.

The Manager shall report for a letter every member of the tennis squad who has won one match of singles and any men who have won one match of doubles in any Maine Intercollegiate Tennis Tournament, unless some cause exists for not doing so, which cause he shall report to the Council; and he may recommend for cause any other members of the squad for their letters.

The Manager of each team shall be awarded a letter of the same style as that of his team at the end of his season, but no Manager shall be awarded his letter until after he has turned over his property to the Graduate Manager and has had his accounts audited and accepted.

The final decision as to the granting or withholding of letters shall lie in the hands of the Council.

Rule 3. Style of "C's" awarded shall be as follows for the various teams:—football, block "C"; baseball, Gothic or round "C"; track, Old English "C"; tennis, German "C".

Rule 4. Colby College is represented on the Maine Intercollegiate Athletic Board by three members, viz., one from the alumni, who has been out of college at least five years and who is not a resident of Waterville, elected by the alumni; one from the faculty, elected by the faculty; and one from the students of the men's college, elected by the students.

Arthur W. Abbott, '14, has been elected captain of the baseball team of the University of Maine for the next spring to take the place of Frank C. Cobb, '12, who did not return to college this fall.

Plans for the construction of a Summer School of Civil Engineering at the Massachusetts Institute of Technology have been completed and work will be started on the buildings next spring.

The United States Bureau of Education will, within the next year, conduct an investigation of American colleges and universities for the purpose of their classification according to the work they do, the type of students they produce, and the value of their bachelors' certificate as a qualification for graduate work.

Columbia has an enrollment of over 8000 students this year.

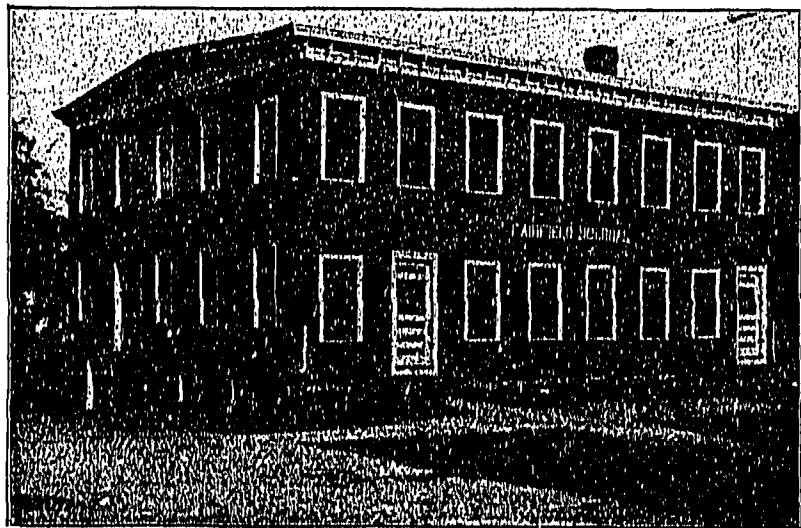

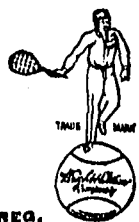

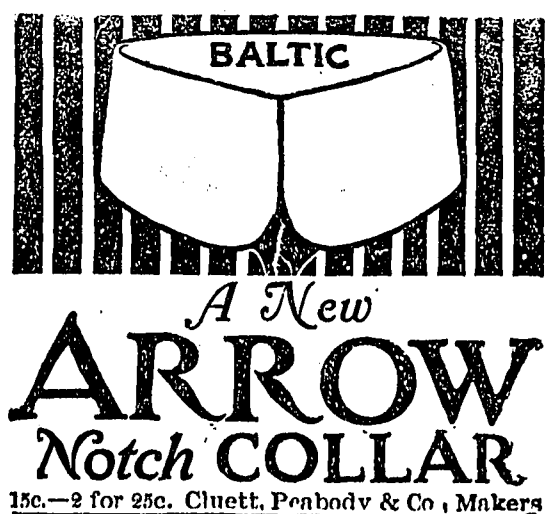
